1. BACKGROUND

Under the Kyoto protocol and based on the "EU Burden- Sharing" Agreement, Italy has committed itself to reduce the emissions of greenhouse gases by 6% during the commitment period 2008-2012 against the base year level.

The Clean Development Mechanism (CDM) is a project-based mechanism under the Kyoto protocol (Article 12). The purpose of the Clean Development Mechanism is to assist Parties not included in Annex I to the UNFCCC in achieving sustainable development and in contributing to the ultimate objective of the UNFCCC, as well as to assist Parties included in Annex I in achieving compliance with their quantified emission limitation and reduction commitments under Article 3 of the Kyoto Protocol.

Republic of Serbia is a Party to the United Nations Framework Convention on Climate Change and has ratified the Kyoto Protocol which came into force on 17 January 2008. The Republic of Serbia has been making a significant effort to implement the Kyoto Protocol and at the same time to use the Clean Development Mechanism (CDM).

Considering that implementation of the CDM, under Article 12 of the Kyoto Protocol, has as results an efficient contribution to the sustainable development and the reduction of greenhouse gases emissions, the Ministry for the Environment, Land and Sea of the Republic of Italy and the Ministry for Environment and Spatial Planning of the Republic of Serbia signed a Memorandum of Understanding (MoU) in order to, among else, maintain and enhance bilateral co-operation in the field of the CDM on the basis of equality, reciprocity and mutual benefit.

Therefore, in order to implement the Annex VII to the mentioned Memorandum of Understanding Serbian Ministry of Environment and Spatial Planning issues a Call for expression of interest for receiving co-financing for preparation of PDDs for the identified CDM projects in the Republic of Serbia.

2. GOAL OF THE CALL FOR EXPRESSION OF INTEREST

The aim of the Call for Expression of Interest is to assist companies interested to invest or raise investments for implementation of identified CDM project activities through receiving co-financing for preparation of Project Design Document (PDD).

Within the Call and in accordance to the Agreement on Donation between the Government of the Republic of Serbia and the Government of the Republic of Italy, precedence shall be given to Italian companies.

The companies shall have technical and other (listed in chapter 6) capacities to develop PDDs for the following identified projects in the Republic of Serbia:

1. AFFORESTATION OF BARE SOILS IN CENTRAL SERBIA
2. POWER AND HEAT PRODUCTION FROM WOOD BIOMASS
3. GRID CONNECTED ELECTRICITY GENERATION USING WIND ENERGY
4. ENERGY EFFICIENCY MEASURES IN HIPOL A.D. FACTORY
5. LFG COLLECTION AND UTILIZATION AT THE LANDFILL "JOVANOVAČ"
6. AWMS METHANE RECOVERY PROJECT , PIK – BECEJ
7. CDM PROJECT ACTIVITY IN BROWN COAL MINE "SOKO", SOKOBANJA, SERBIA

3. PROCEDURE

The Call for Expression of Interest will be conducted pursuant the procedure and the criteria set by the Steering Committee established according to the Annex III to the Memorandum of Understanding between the Italian Ministry for the Environment, Land and Sea and the Serbian Ministry of Environment and Spatial Planning.

The Call for Expression of Interest is issued by the Serbian Ministry of Environment and Spatial Planning, in accordance with the Annex VII to the MoU and the Agreement on Donation signed on 5 May 2009 in Roma, Italy.

Applicants interested **to invest into implementation** of identified CDM project activities are invited to express their interest for receiving co-financing for preparation of PDD for identified project/s and to respectively justify their administrative, technical and financial capacity.

Steering Committee will review the documentation received from the Applicants and select the companies that best fulfill conditions listed below in this document to receive co-financing for the preparation of PDDs for the potential CDM projects in the Republic of Serbia.

After finishing the evaluation procedure, the Ministry of Environment and Spatial Planning of the Republic of Serbia (hereinafter the Ministry) shall sign a contract with the successful Applicant in order to allocate the assigned co-financing for the preparation of the PDD.

The first lot of the money assigned for co-financing will be disbursed to the Applicant after the signature of the financing contract. The balance shall be disbursed after submission of the PDD by the Applicant to the DOE for validation. Prior to submission of the PDD to the DOE, the PDD has to be positively evaluated by the Ministry as a co-financier. Positive evaluation obtained from the Ministry does not imply official approval by the DNA.

The selected Company/ies shall submit the completed PDD within 3 months from the signing of the financing contract. Based on existing agreements between the Ministry of Environment and

Spatial Planning of the Republic of Serbia and the site owners (in terms of CDM) for each identified CDM project, company/ies producing the PDD are granted a pre-emptive right to negotiate with the site owner (in terms of CDM) towards the implementation the project within six months from the positive evaluation of the PDD by the Ministry.

4. DOCUMENTS REQUIRED FOR THE EXPRESSION OF INTEREST

Applicants are required to submit the complete documentation listed below. In case an incomplete documentation is submitted, the Steering Committee reserves the right to reject the Expression of Interest.

If the Applicants are applying jointly, the Lead Applicant needs to be clearly identified.

In case of participation as a temporary association of companies or as a not yet formally established consortium, the legal representative of each company shall undertake, in case of selection, respectively to grant full power of legal representation to the Lead Applicant to sign the financing contract on behalf of the temporary association, or to establish the consortium.

The Applicants need to submit the listed items with the Expression of Interest:

- a) Cover letter (Attachment I)
- b) General information (Attachment II)
- c) Proof of legal existence - recent extract from a Professional or Trade Register, or equivalent documentation
- d) Declaration on exclusion criteria (Attachment III)
- e) Proof of financial capacity (year-end balance sheets and profit and loss accounts for the past 3 financial years), with summary table for selected indicators over the past 3 years (Attachment IV)
- f) Letter of Intention to Invest (Attachment V)
- g) Reference list of key projects carried out by the Applicant (Attachment VI)
- h) Resumes (EC format) of the project team members, with summary table (Attachment VII)

If applying for more than one project, the Applicant can provide a single copy of items c, d, e, f, g.

In case of joint Applications (e.g. consortium), Applicants are required to submit - for each project, in case of application for more than one project - a single Attachment I (cover letter) and a single Attachment VII (Project team members) while supplying separate information under items b, c, d, e, f, g.

In the case of joint Applications, the proposed project team should be the expression of the joint effort of the Applicants.

The Steering Committee may request the submission of additional information concerning the submitted documentation for clarification purposes.

5. SUBMISSION OF THE EXPRESSION OF INTEREST - TIME SCHEDULE AND DEADLINES

The Call for Expression of Interest is opened till July 10, 2009.

Expression of Interest shall have to be submitted as hard copy and as electronic version (CD). All documents will have to be submitted in English language (with the exception of official documents, such as certifications and financial statements, which can be enclosed in the language of origin) and received at the address below:

Any Expression of Interest received after the deadline will not be considered.

Each Applicant shall be informed in writing of the outcome of the selection process within 6 weeks from the expiration of the deadline for submission.

The Ministry will not reimburse any cost for the Expression of Interest or any expenses in relation to the submission of the Expression of Interest.

6. SELECTION CRITERIA

Applicants will be assessed on the following criteria:

6.1. Exclusion criterion

Ineligibility

Any Applicant will be excluded from participation if he:

- a) is bankrupt or is being wound up, whose affairs are being administered by the court, who has entered into an arrangement with creditors, who has suspended business activities or who is in any analogous situation arising from a similar procedure under national laws and regulations;
- b) is the subject of proceedings for a declaration of bankruptcy, for an order for compulsory winding-up or administration by the court or for an arrangement with creditors or of any other similar proceedings under national laws or regulations;
- c) has been convicted of an offence concerning his professional conduct by a judgment which has the force of res judicata;
- d) has been guilty of grave professional misconduct proven by any means which the Ministry can justify;
- e) has not fulfilled obligations relating to the payment of social security contributions in accordance with the Italian legislation or legal provisions of the country in which he is established;
- f) has not fulfilled obligations relating to the payment of taxes in accordance with the Italian legislation or with the legal provisions of the country where he is established;
- g) is guilty of serious misrepresentation in supplying or failing to supply the information that may be required under this Call for Expression of Interest on the criteria for qualitative selection.

6.2. Qualitative criteria

Registration

In order to participate in the Call, Italian companies must prove enrolment in a professional or trade register. Relevant professional and trade registers or declarations or certificates in the Republic of Italy are the “Registro della Camera di commercio, industria, agricoltura e artigianato”, the “Registro delle commissioni provinciali per l’artigianato” or the “Consiglio nazionale degli ordini professionali”. Recent extract from such a register should therefore be submitted.

Technical and professional capacity

The Applicant should possess proven technical and professional capacity in designing and developing CDM projects.

The technical capacity of the Applicant will be assessed by using indicators such as:

- Key expertise/core business of the Applicant/s, years of operations, permanent technical staff;
- Previous experience of the Applicant/s in similar projects;
- Professional experience of the Applicant/s in the Balkan countries;
- Strength of proposed project team (training, professional qualifications, regional experience, years in the business).

Financial and economic standing

The financial and economic standing of the Applicant will be assessed based on, amongst others, the following indicators:

- Net equity,
- Net assets,
- Total sales,
- EBIT.

Intention to invest

A proven intention to invest or to raise investment in the implementation of the CDM project activity of interest within this Call shall be positively evaluated. Such interest should be expressed through the Letter of Intention to Invest (given in Attachment V).
